## **Mission Statement**

## **Administrative Authority**

Gateway Christian School is a ministry of Gateway Church International and falls underneath the elder board which govern all aspects of Gateway Church.

## **Accreditation**

Gateway Christian School is accredited by the Association of Christian Schools International and by the State of New Mexico for K-5 through 12th grade.

## **Educational Philosophy**

The predominant curriculum used at GCS is A BEKA and Bob Jones. These are excellent curriculums emphasizing “traditional” education, high academic standards, phonetic reading and integration of Biblical principles. They are designed for the “traditional” or self-contained classroom.

There are several distinctive factors that set GCS apart from public schools, as well as many other private schools:

1. Teachers are willing and quick to pray with students and parents.
2. The administration maintains daily morning devotions for the staff.
3. Teachers have been hired who have a Christian philosophy of education and consider teaching a ministry and a divine calling.
4. Teachers, as well as the curriculum, integrate the Word of God into every subject.
5. School programs and activities are evaluated in the light of scriptural principles and are implemented with the clear purpose of developing our uniquely Christian goals.
6. Athletic programs are monitored to maintain a standard for building sportsmanship and character.
7. Teachers, staff and administrators demonstrate a Godly lifestyle and are professional educators qualified for their positions.
8. Discipline is based on Biblical principles.

## **Admissions**

Gateway Christian School is a faith-based institution providing an education in a distinct Christian environment, and it believes that it's Biblical role is to work in conjunction with the home to mold students to be Christ-like. On those occasions in which the atmosphere or conduct within a particular home is counter to or in opposition to the Biblical lifestyle the school teaches, the school reserves the right, within it's sole discretion, to refuse admission of an applicant or to discontinue enrollment of a student. This includes but is not necessarily limited to, living in, condoning, or supporting sexual immorality; practicing homosexual lifestyle or alternative gender identity; promoting such practices; or otherwise having the inability to support the moral principles of the school.

Admission into Gateway Christian School is a privilege. Parents wishing to obtain information about the school and it's programs or wishing to enroll their children in the school should contact the central office. It is necessary for these matters to be taken care of as soon as possible in order for class space to be assured. If a student has been suspended or expelled for any reason from another school, he/she may not be admitted into GCS. The following admission requirements must all be met before a student will be admitted or readmitted to Gateway Christian School.

### **New Enrollment**

#### Registration packet

Registration packets are available at the front office or on the website. Placement exam will be scheduled when a packet is picked up.

#### Placement exam

All new applicants (grades K-5-12) must take a placement exam. This exam takes approximately two hours. The testing fee of \$25 and the registration packet is due on the test date. The administrative staff will consider the test results and past academic performance to determine grade placement for all new students.

#### Interview

Before acceptance, an interview between the parents and the Acceptance Committee will be conducted. Parents must bring the student's report card or school record of progress from the student's previous school. Placement test results are reviewed. Parents will be notified of the committee's decision as soon as possible.

#### Enrollment Packet

After the student has been accepted, the school will email information to complete the enrollment process online. The online enrollment fee is \$25 per student and is payable online. The student will not be allowed to start school until the online enrollment process is complete.

#### Immunizations

All students must submit verification of state-required immunizations before the first day of school (State Law).

#### Registration and Book Fees

A non-refundable, non-transferable registration fee is required to hold the student's place. Please make note of the "Early Bird" registration fee offered. The entire registration process must be completed along with forms

submitted before the “Early Bird” fee can be applied. The book fees are due in full in July.

### **Re-enrollment**

Re-enrollment begins in early Spring. Enrollment is offered to families in school first. This includes siblings that are not currently enrolled. Registration is opened to the public two weeks after enrollment begins. Registration fees are required to hold a student’s place.

## **Finances**

### **Financial Policy**

Tuition may be paid monthly, semi-annually or annually. You choose your preferred type of payment plan when you register online. A Billing Statement from FACTS will be sent five days before payment is due as a reminder. If payment is not received by the date you have set, FACTS will then notify you by text, email and a phone call that payment is due.

If a payment is returned, FACTS will charge a \$30.00 one time fee, and then will attempt to withdraw the payment two more times.

Fees and enrollments, absences, etc.

Since Gateway Christian School has an obligation to its employees, students are considered enrolled for the entire school year. Tuition is calculated on the basis of the entire year; therefore, no reductions can be made for vacations or school holidays. If a student leaves the school for any reason or enters after the school year has begun, then charges are pro-rated according to actual number of days enrolled. No deductions will be made on tuition for absence during the school year regardless of the cause of such absence. If there is withdrawal after the first of the month, the parent will be responsible for the entire month’s tuition. The scholastic records will not be transferred until the exit interview process is completed, the necessary forms are signed and all outstanding fees are paid.

Report Cards

All accounts must be paid in full before the yearly report cards will be issued.

### **Financial Aid Policy/Guidelines**

Providing capable student’s access to Gateway Christian School, regardless of financial means, is a priority for us. We offer need-based financial aid and flexible payment plans to make the investment in our school manageable.

Need for financial aid is assessed by Gateway School using Confidential Financial Services (CFS) and is awarded on a yearly basis. Families must reapply for aid, using CFS each year.

The school also has two foundations that offer financial assistance. Applications are available at the school office.

### **Statement of Purpose**

The purpose of Gateway Christian School's need-based financial aid program is to support the mission of the school and our commitment to being diverse and an inclusive community providing a superior education to qualified students who could not otherwise afford to attend.

### **Financial Aid Policy**

Financial aid decisions are determined by the Gateway Christian School Financial Aid committee by an analysis of each family's financial situation, thru a report sent to the school from CFS.

Gateway School believes the family bears the primary responsibility for funding their child's education and will not fund 100% of the cost of tuition. Financial aid is limited each year, so a family only receives a percentage amount of their year's tuition dependent on the amount of families in need and aid available. If the gap between the parent's stated ability to pay and the School's available financial aid is deemed too significant, the School may not be able to grant an award.

Gateway does not discriminate in the administration of its financial aid policies due to race, religion, national or ethnic origin, gender or age.

Financial aid will not be calculated or granted to those students with outstanding balances of tuition and/or fees.

Gateway reserves the right to withdraw financial aid at any time if discrepancies in financial information provided are found.

### **How to Apply for Financial Aid**

Gateway School has several options for financial assistance.

1. Gateway uses Confidential Financial Services (CFS) for the evaluation of financial data. Families must adhere to all deadlines and policies and must reapply each year. The school's five digit code: 29710
2. The McCutchen Foundation and Conner Christian Scholarship Foundation are available for grades 1-12. These foundations award aid based on financial need.

**Students must apply for admission and be accepted before a financial aid award can be offered. Financial aid awards can only be finalized after enrollment is accepted and a financial aid grant is offered.**

## **Academics/Curriculum**

Gateway Christian School uses excellent curriculum emphasizing “traditional” education, high academic standards and integration of Biblical principles. Most courses are ABEKA or Bob Jones. It is designed for the traditional classroom. The high school courses are designed to be college prep.

### **FACTS**

FACTS is web-based school management software. FACTS is a private and secure portal that will allow parents to view academic information specific to your children. You can see your child’s grades, homework and conduct, as well as other useful school information, including announcements, family billing, and resource documents. Your child (grade 3 and up) will be able to set up a student account using their school e-mail. The link is found on the school website [gatewaychristianschool.us](http://gatewaychristianschool.us) under the Parent Info menu. Click on Parents Login. Our district code is GCS-NM.

### **Class Schedule**

Class schedules will be available to students at an open house/orientation the week before school begins in the fall. The student or parent may pick up the schedules at that time. Class schedules may be viewed in FACTS. Any scheduling concerns should be addressed before school begins. Students will not be able to drop or add a class after the first week of the semester.

### **Grades**

Grades may be viewed at any time online thru FACTS. Grades are posted weekly on FACTS. An auto-generated email is sent to parents each week. The parents will also be notified by an auto-generated email if a grade below 70 or missing is entered in the gradebook.

**Middle School Grades:** Middle School courses are based on quarter grades averaged for a yearly grade. The yearly grade is recorded on the student’s permanent record. All grades recorded on report cards and permanent records are numeric based on 100%.

**High School Grades:** All High School courses are based on semester grades. The grade is determined using the quarter grades (40% each) and a semester exam (20%). The semester grade is recorded as a letter grade on the transcript.

### **G Suite for Education**

G Suite for Education includes apps such as Gmail, Google Docs, Slides, Sheets, Forms, Drive, Google Classroom and more. It helps your child communicate and collaborate at school or home on any device, all within a secure environment. Each student is issued a school email that enables them access. Your child’s email is found in FACTS under “Family”. Use the drop down box to select your child.

### **Chromebooks**

Chromebooks run on the Google operating system Chrome OS. Chromebooks are issued to 6<sup>th</sup>-12<sup>th</sup> graders. A chromebook contract must be signed by a parent/guardian and the student. The contract includes agreeing to the Tech Policy and replacement/repair costs if the chromebook is lost or damaged.

### **Tech Policy**

Gateway Christian School is very pleased to offer students access to the Internet. Use of the Internet will be an integral component of some courses. Our goal in providing this service is to promote educational excellence through the use of this unique tool.

#### The Student Agrees to the Following Terms and Conditions

1. The student agrees to act responsibly and with good behavior on any computer or communications system using Gateway Christian School's network services. The student agrees to follow all school rules for behavior and communications. Access is a privilege – not a right.
2. The Internet is provided for students to conduct research and communicate with others for educational purposes **ONLY**.
3. The student agrees not to use the computing resources for commercial purposes, product advertising, political lobbying, political campaigning, or any other personal use not associated with an educational objective.
4. The student agrees not to transmit, receive, submit, or publish any defamatory, inaccurate, abusive, obscene, profane, sexually oriented, threatening, offensive, or illegal material.
5. The student agrees **NOT** to install or use **ANY** software on Gateway Christian School's computers, including, but not limited to, games, chat clients, e-mail clients, instant messaging, and other non-authorized applications or utilities, without the expressed permission of the administration of Gateway Christian School. Downloading of software from the Internet is permitted only for software that falls within the scope of a class assignment and only with explicit permission by the computer teacher and the school administration.
6. The student agrees **NOT** to tamper with or attempt to illegally access or “hack” any Gateway Christian School computer resources, or change configurations. Intentional damage of computers or computer networks is unacceptable. The intentional creation or spreading of a computer virus will not be tolerated.
7. The student agrees to abide by all patent, trademark, trade name, and copyright laws. Plagiarism in any form will not be tolerated. All sources must be cited.
8. Security on any computer system is a high priority. If a student feels he/she can identify a security problem in Gateway Christian School's computer systems, he/she agrees to notify a staff member immediately. The student agrees not to demonstrate the problem to others. The student understands and agrees that using someone else's password or trespassing in another's files without written permission is prohibited, and that attempts to logon to the networks as anyone other than himself/herself is unacceptable.
9. Gateway Christian School makes no warranties of any kind, whether expressed or implied, for the supervision and service it is providing. The student who signs this agreement agrees that Gateway Christian School assumes no responsibility or liability for any loss of data resulting from delays, non-deliveries, mis-deliveries, or service interruptions caused by its own negligence or user errors or omissions. Use of any information obtained via the

Internet is at the student's own risk. Gateway Christian School specifically denies any responsibility for the accuracy or quality of information obtained through its internet services.

10. All communications and information accessible via the computer resources shall **NOT** be regarded as private. The student agrees and consents to allow Gateway Christian School personnel to review any and all files, data and messages to ensure that students are using the system responsibly at any time with or without notice.

Any violation of the Appropriate Use Policy will result in disciplinary action. Such action might include suspension or revocation of Internet privilege, suspension or expulsion from school, and/or legal action. Students are subject to all local, state, and federal laws and understand that illegal activities may be reported to the appropriate law enforcement authorities. The student agrees to report any violation of the Acceptable Use Policy observed by the student to Gateway Christian School staff immediately.

## **Homework**

Assignments and homework are an essential part of a good school program. They will vary from light assignments for the lower elementary grades to longer assignments for upper grades. The amount of homework a student has to do at home may depend upon how efficiently the student uses his/her time in school.

### **Reasons for Homework**

*For practice* - Following classroom explanation, illustration and drill on new work, homework is given so that the material will be mastered.

*For remedial activity* - As instruction progresses, various difficulties become evident in a student's grasp of a subject; homework following instruction is given to overcome such difficulties.

*For special projects* - Book reports, compositions, special research assignments, and projects are some of the activities that are frequently assigned as homework.

### **Amount of Time MS & HS**

For the average student, the normal homework assignments in grades 6-12 should take 30 minutes per subject to complete. The amount of homework may vary depending on the amount of work the student does in class. **NO HOMEWORK WILL BE ASSIGNED ON WEDNESDAYS, (NOR WILL ANY TESTS BE ADMINISTERED ON THURSDAYS), AS WE WANT TO ENCOURAGE OUR STUDENTS TO SUPPORT THEIR CHURCH AND ATTEND WEDNESDAY NIGHT SERVICES.** In addition, because we realize how important family time is, Friday homework will be limited (to allow the student to spend quality time with his/her family).

### **Parent Cooperation**

We do request the parents' full cooperation in seeing that the assignments are completed. Because homework is part of preparation for the future, every student is expected to complete his/her homework. Repeated delinquent homework will result in lower grades and discipline from the teachers. Parents are encouraged to communicate with the teachers when their children are having difficulties with homework, and the teachers will notify parents if a student is not turning in assigned homework.

### **Late Assignment Policy**

- A standard late assignment policy will be enforced in each classroom. Credit for the “late assignment” will be computed according to the following guidelines:
  - One day late=25% deduction of graded paper
  - Two days late or more=0 for the grade
- Teachers may adjust their assignment policy slightly to allow for additional opportunities.
- Partial attendance for the school day still requires all assignments to be turned in for that day plus assignments for the classes that were missed.

### **Parent/Teacher Conferences**

A parent/teacher conference day is scheduled at the end of the 1<sup>st</sup> and 3<sup>rd</sup> quarters. Consult the school calendar for the exact dates. If for any reason parents would like to meet with a teacher or administrator other than at the assigned times, they may call and make arrangements. We ask that the Matthew 18 principle be used to resolve any conflict (see *Grievances* for information on how to resolve conflict). Direct communication with those involved in any conflict will usually resolve the problem.

### **Dual Enrollment/Concurrent Enrollment**

All high school students may take concurrent enrollment classes from ENMU-R. The grade received will appear only on the ENMU-R transcript. The class is tuition free, but the books and any fees will be the responsibility of the student. The class cannot interfere with the school day.

Selected courses required for graduation are provided through dual enrollment with ENMU-R. Parents and students will be notified if a course requires dual enrollment. Dual enrollment grades are recorded on both the GCS transcript and ENMU-R transcript.

When enrolled in college courses the instructors treat all students as adults. Due dates are firm and the grade received is part of their permanent college transcript history. All classes will transfer in state.

### **Transcripts**

Seniors are assessed a \$30.00 fee. The fee will cover all transcript requests during their senior year as well as after graduation. This fee will also help cover costs associated with graduation (i.e. diplomas). Requests for transcripts must be made thru the high school office. 6-semester transcripts are sent during the fall semester. 7-semester transcripts are sent during the spring semester. Final transcripts are available one week following graduation.

### **Graduation Requirements**

Minimum scholastic requirements for graduation from Gateway Christian School High School shall be 25 credits.

\*One of the above credits must be dual credit.

All seniors must be attend at least 5 class periods. If credit requirements are met, seniors may enroll in concurrent college classes. All 5 class period must be in physical attendance.

### **Valedictorian/Salutarian/Honor Graduates**

The graduating senior with the highest cumulative GPA will be named valedictorian of the class. The runner-up will be named salutarian. To qualify for valedictorian or salutarian, the student must have attended GCS for at least their entire junior and senior year. Only students who have attended accredited institutions will be considered for valedictorian and salutarian. A graduate must carry at least a 3.5 GPA or above to be able to graduate with honors.

### **Honor Society**

Honor society is provided for students in grades 10-12. A student must carry a 3.5 GPA to be nominated. Officers are elected each fall.

### **Student Council**

A student council member is elected by peers and represents the student body. Representatives are chosen from grades 9-12. Officers are elected from the upper grades. Their purpose is to:

- Plan special days and projects for the school
- Become the spiritual leaders of the school

### **Standardized Testing**

#### **NWEA MAP Growth**

**K-5-10th graders** will take the MAP Growth tests from NWEA on a chromebook. The Growth test is administered in August, January, and April/May. MAP Growth scores help teachers check student performance by measuring achievement and growth. Following each testing period, you will receive a Family Report showing a summary of how your child is performing academically. Teachers use results to tailor classroom lessons and set goals for students.

MAP Growth tests are unique, and adapt to your child's responses to measure their skill level. If your child answers a question correctly, the next question is more challenging. If they answer incorrectly, the next one is easier. These results will provide a more complete picture of what your child knows and is ready to learn—whether on, above, or below their grade level. #### **PSAT/NMSQT**

The Preliminary SAT/National Merit Scholarship Qualifying Test (PSAT/NMSQT) Is A Standardized Test Administered By The College Board And Cosponsored By The National Merit Scholarship Corporation (NMSC) In The United States. Scores From The PSAT/NMSQT Are Used To Determine Eligibility And Qualification For The National Merit Scholarship Program.

All **juniors** take the PSAT/NMSQT in mid-October. **Sophomores** may take the test for a small fee.

### **PreACT and PreACT 8/9**

PreACT assessments provide 8th, 9th, 10th and 11th grade students an early measure of College and Career Readiness while serving as a practice opportunity for the ACT® test.

**8th-11th graders** take the PreACT or PreACT 8/9 in mid-March.

### **ACT**

The ACT is a standardized test used for college admissions in the United States. It is currently administered by ACT, a nonprofit organization of the same name. The ACT test covers four academic skill areas: English, mathematics, reading, and scientific reasoning. It is accepted by all four-year colleges and universities in the United States as well as more than 225 universities outside of the U.S.

**Seniors** take the ACT in October. **Juniors** take the ACT in April

## **Physical Education**

Excuses: If a student has a physical challenge that limits or prohibits a particular activity, the school requires a note from the family medical doctor indicating the reason for limitation and the period of time for which the limitation is valid. Parent request for exemption (sore throat, nausea, etc.) can only be honored for two days without a doctor's notice.

## **Chapel**

Chapel will be held each Wednesday morning at 11:20 - 12:20 noon for 6<sup>th</sup> through 12<sup>th</sup> grade (unless there is a necessary day or time change to accommodate a special program). The students meet in the church auditorium. Parents are invited to attend any of these chapels. Chapel is a well-disciplined setting in which students learn more about God, worship and Biblical truths which will prepare them for the rest of their lives. In addition, various awards and announcements will be given at chapel.

## **Field Trips**

Field trips are planned throughout the school year. Parents are requested to assist in supervision and/or transportation.

1. A **medical form** must be on file and a field trip release must be submitted to the teacher before a child is allowed to go on any field trip.
2. Every volunteer is required to have a **felony misdemeanor form** on file before he/she is allowed to help with any field trips.
3. The school must have on file a copy of both the **driver's license and proof of current car insurance** for any volunteer interested in helping with transportation for field trips.

Releases/Permission Slips must be signed by a parent/guardian and turned into the student's teacher for **every** off-campus outing/field trip. If the student does not have a signed release or permission slip on the day of the outing/field trip, he/she will not be allowed to leave campus. In this case, the student will be asked to stay with another teacher until either the class returns from their outing or for the remainder of the school day.

## **Extracurricular**

Academics have priority over extra-curricular activities. Students must attend school on the day of an extracurricular activity. Exceptions to this policy may include: doctor/dentist

appointment or a funeral (in which case, he/she must return to school immediately following the appointment). The administration reserves the right to make exceptions when necessary. Because all homework assignments are posted each Friday for the following week, athletes must turn in any academic work or and major projects on the due date (regardless of whether or not he/she attends class on the day of the extra-curricular activity). If a quiz or test was announced prior to the day that is missed, the student will be responsible to take the quiz/test upon returning to class. Students should not expect teachers to alter their schedule of tests, quizzes or assignments because of their schedule. If a student has difficulty managing extra-curricular activities and academics, he/she needs to withdraw from or curtail participation in them.

ACSI, our accrediting organization, sponsors the following event:

NMAA Athletics are a vital part of the educational process and are an important component in fulfilling the vision of GCS. The MS/HS participates in the following sports. In regards to athletics MS is restricted to 7<sup>th</sup> and 8<sup>th</sup> grades only.

Fall-Cross Country, Football, and Volleyball

Winter-Basketball & Swim

Spring-Track, Golf and Baseball

GCS follows the all NMAA guidelines including eligibility. See *Athletic Handbook - "Player Eligibility"*.

## Behavior

### Discipline Policy

GCS has designed it's discipline system to help maintain order in the classroom and to give a graduated system of consequences to discourage the continuation of unacceptable behavior.

### Discipline

The goal of GCS is not to reform, but to teach and train students in a well-disciplined environment where they can grow spiritually as well as academically. Discipline is necessary for the welfare of each student, as well as for the entire student body in a manner consistent with Biblical principles. Even as the Father disciplines us in love, so the faculty at GCS will endeavor to always discipline in love. Discipline is designed to instruct and train individuals, and to remind them of God's line of authority as revealed in His Word. Discipline will be administered in love, with forgiveness, restoration, and training as the ultimate goals. GCS faculty may discipline through instruction, exhortation, correction, rebuke, and other disciplinary actions (i.e. detention, suspension).

### Parents' Responsibility

Parents will be responsible for counseling their children at home regarding misbehavior at school. They will be expected to exemplify a caring and respectful attitude toward teachers, administration and for other students. All parents are expected to adhere to the Matthew 18 principle to resolve any conflict (see

*Grievances*). *Direct communication* with those involved in any conflict will usually resolve most problems.

#### Students' Responsibility

Students will be responsible for their actions and shall conduct themselves appropriately in keeping with their level of maturity. They will be expected to exemplify a caring and respectful attitude toward fellow students and for persons in authority. At no time shall a student be discourteous to a teacher in speech or in action. Swift administrative action will follow a challenge to or disrespect for authority. Being subject to and giving respect to those in authority is clearly taught in the Word of God. As a member of Gateway Christian School, students should set a good example for others. Students should be a credit to their parents, their school, and to themselves and should be pleasing to the Lord. Students should do unto others what Jesus would have them do. All students in grades 6-12 must sign a student contract before admission into Gateway Christian School.

#### Teachers' Responsibility

The teachers are given the responsibility for discipline in their classroom. Each teacher will make every effort to counsel the student to resolve any problems that may arise. Whenever possible, the teacher will attempt to work out the problem with the student without administrative involvement. If a teacher deems that the student needs further counseling or disciplinary action, he/she will send the student to the principal.

#### Principal's Responsibility

The principal has the authority given him/her by the school board to administer paddling, assign in-school or off-campus suspension, or to recommend expulsion to the board. Parents will be informed of any major disciplinary action taken. *Regarding paddling of students: Parents must sign the "Discipline Release" clause (on the student application form) giving the principal permission to administer paddling. Please refer to this form for clarification on this process.*

### **Guidelines for Expected Conduct**

The Bible is always and only the ultimate authority on which behaviors are right or wrong; although it does not list every single "do" and "don't" regarding Gateway Christian School, it's principles form the basis for all rules and regulations at GCS. While the following guidelines do not aim to be complete; they do call attention to some of the items that should be considered and obeyed by the students in their daily behavior:

- Students will demonstrate respect for teachers and all school staff at all times.
- Students will be respectful and considerate of other students in attitudes, words and actions.
- Profane and inappropriate language and obscene gestures will not be tolerated.
- The students will pay for any damage to school facilities or furniture that they incur.
- Students will do their own work.
- Students will comply with all classroom rules set by the teacher.
- No cell phones are to be used during school hours.
- Students will be on time for school.

- Students will not leave the campus without permission from the school office.
- Food and drink are confined to lunch areas.
- Skates or skateboards will not be allowed on school or church property.
- Students will not be allowed in a classroom before or after school unless prior approval has been granted.
- Horseplay will not be permissible in the school building, on the school grounds or while riding school vehicles.
- Students will not be involved with alcohol, drugs, or tobacco, on or off campus, with the understanding that violation of this rule can result in suspension or permanent expulsion from GCS.
- Public Display of Affection (“PDA”) is not tolerated on school property, in the student’s vehicle or at any in school or extra-curricular school function. (i.e. hugging, kissing, holding hands, etc. is not allowed)
- No student will have in his/her possession (on person, in desk, in vehicle, on campus, etc.) any kind of fireworks, explosives, knives or other weapons. These items will be confiscated in addition to further consequences.
- Because GCS takes a strong stand against ungodly music, movies, videos, video games, musical themes and/or lyrics, anything that is deemed (by school administration) to fit into this category will not be allowed on school grounds or at any school-related events.
- Visible body piercing (except ear lobes for females) or tattoos are not allowed at school or school functions.

**\*All of the aforementioned offenses are reasons for various disciplinary measures (i.e. instruction, correction, rebuke, paddling, detention, suspension, or permanent student dismissal).**

### **Discipline Policy**

GCS has designed its discipline system to help maintain order in the classroom and to give a graduated system of punishment to discourage the continuation of unacceptable behavior. GCS has also split the infractions into minor and major offenses to make the punishment fit the offense. All GCS teachers will be using the same disciplinary system. This uniform disciplinary system will help to provide a better environment for learning. A behavior report will be filled out by the administrator and the parent will be notified if a discipline action is required.

**Detentions**-used for minor offenses

Detention can be served during lunch, after school, or otherwise if deemed necessary by the principal.

**Suspension** - used for major offenses such as:

- Fighting/acts of violence: mandatory suspension (and possible call to police department)
- Any major offense as determined by faculty
- Repeated minor offences

**Suspension Consequences:**

- Meeting with principal
- Not allowed on school grounds
- Student will receive zeros (0) for all missed work, tests, quizzes, etc.
- **FAILURE TO FOLLOW RULES OF SUSPENSION: POSSIBLE EXPULSION FROM GCS**

- NO PARTICIPATION IN ANY EXTRA CURRICULAR ACTIVITIES DURING SUSPENSION.

### Grievances

Should any parent have a grievance against any fellow parents, or any teachers, coaches, principals, superintendent and/or any other individual associated with either Gateway Christian School or Gateway Church International, he/she must follow the order of confrontation outlined in the Scriptures (Matthew 18:15-20). **Pray** about the grievance and ask the Holy Spirit for wisdom in how to deal with the matter at hand. **Arrange to meet** with the individual associated with the grievance (i.e. fellow parent, teacher, principal and/or superintendent) in person to discuss the matter openly and in a peaceable manner. He/She must come willing to listen, communicate peaceably, and willing to come to some kind of compromise. **He/She must NOT discuss the matter with outside persons (i.e. those who are not part of the problem or part of the solution).**

- **If an agreement/solution is not reached**, the parent may then bring the matter to the next level of authority (i.e. the immediate supervisor of the person with whom he/she is grieved). At this meeting, the “grieved party” will again come willing to listen, communicate peaceably, and willing to come to some kind of compromise. **He/She will NOT discuss the matter with outside persons (i.e. those who are not part of the problem or part of the solution).** The parent and the higher authority figure will discuss what to do from this point on.
- **If an agreement/solution is still not reached** in this final meeting, the parent must then make a decision to either:
  - Withdraw his/her student from GCS; or
  - Submit peaceably to the authority figures at GCS. In this case, the parent/guardian will NOT discuss the grievance further, nor will he/she slander the persons involved (neither to outside persons or to his/her own children).

## Expectations

### Attendance

Regular and timely attendance is essential for maintaining a good academic record. Excessive tardiness and absences affect both the student’s grades and attitude.

### Absence Policy

Students are allowed 10 days of absences per semester. Students will be allowed to make up work resulting from excused absences: in this case, the students will have the same number of days to make up their work as they were absent. Should a student miss more than 10 days per semester, he/she may lose credit for those classes. (Extended illness will

be taken into consideration.) Final decision regarding loss of credit will be determined by the administration. Students who exceed the limit must attend a Saturday school for each day past the 10-day rule.

If an absence is foreseeable, a note or call should be made in advance. If the absence is unexpected, the parent/guardian should call the high school office by 9:00 am that day to inform the office of the student's situation/condition. When medical/dental/orthodontic appointments are necessary, parents should make appointments after school hours or at varying times so the student does not miss the same class repeatedly. It is the responsibility of the student to make arrangements to make up any missed work. Partial attendance for the school day still requires all homework to be turned in for that day plus assignments for the classes that were missed.

### **Tardy Policy**

A student will be considered "tardy" if he/she arrives in a class after the scheduled start. If a student misses more than 1/3 of a class (i.e. 15 minutes of a 45 minute class) the student will be considered absent. Tardy means that the student has arrived in a class after the scheduled start. Tardiness hinders the student's learning and interrupts both classmates and the teacher; it is a sign of irresponsibility and should not become habitual. If a student is tardy they must receive a tardy slip from the office to enter class. Teachers and school office will keep a record of all tardies and absences.

#### **Disciplinary Action for Tardies:**

- 5th tardy in a 9-week period = Detention
- Junior and seniors loss of lunch privileges
- After school detention
- Principal's discretion

#### **Disciplinary Action for Skipping Classes:**

- Meeting with Principal to determine punishment
- NOT ALLOWED to turn in any late work for the missed school day(s) - the student will receive zeros (0) for all missed work, tests, quizzes, etc.

### **Student Withdrawal**

Withdrawal of a student from school requires an exit interview with the proper school official to discuss the reasons for withdrawal. If there is withdrawal after the first of the month, the parent will be responsible for the entire month's tuition. The scholastic records will not be transferred until the exit interview process is completed, the necessary forms are signed and all outstanding fees are paid.

### **Dress Code**

The students' dress is to reflect MODESTY and is to identify the student with Christ, not with the world. Although the Bible does not say precisely what kind of clothes a Christian should wear, it does say to every generation that their appearance must be modest. Boys should dress masculine. Girls should dress feminine. Because student dress will affect the entire atmosphere of the school i.e. academic achievement, student attitude and student behavior, the following dress code has been established and will be adhered to by the student body of Gateway Christian School. (The faculty of GCS adheres to its own teacher dress code.)

**Any solid color** Pullover Polo shirts, long or short sleeve.

Pullover polos must have buttons, logos no larger than a quarter

**Any solid color** Oxford Shirt, long or short sleeve

Must be tucked in at all times, not tight or form fitting

Must be fully buttoned at all times except for top button

No sleeveless shirts

SHORTS

Docker style with belt loops

Not form fitting

No shorter than 3 inches from the knee

SWEATERS & JACKETS

**Any solid color** or style

It is not to be tight, and must be worn over the polo or oxford shirt

**Any solid color** sweater or jacket with no writing may be worn or Gateway Jacket

SWEATSHIRTS

Must be a Gateway sweatshirt

SHOES

Tennis shoes or any other shoe, boot, or sandal

**No high heels for elementary**

No rubber sole flip-flops of any kind

Blue jeans, must not be torn or worn out.

NOT form fitting or tight

NO skinny jeans

#### HAIR:

Hair length for boys should not extend below the bottom of the collar  
Hair should stay out of the eyes  
Hair should be natural colors  
Hair should be neat and clean

## **Health and Safety**

### **Closed Campus**

Any student leaving the school grounds during the school day must check out through the high school office. Teachers are not allowed to release students from their classes without notification from the office. In order for a student to leave school grounds, he/she needs either a written statement from home, a phone call from the parent, or the appearance of the parent at school to check the student out.

#### Junior & Senior Privileges

Only junior and seniors at Gateway Christian High School will be allowed to leave campus during the lunch time. This “Junior-Senior Privilege” may be revoked at any time if abused.

#### Doctor Appointments

If a student has a doctor appointment and can drive his/her self to the doctor, then a call from the parent will be required before the office will let the child be dismissed from school. When the student returns to campus, he/she must check back in through the high school office.

#### Lunch

During lunch time parents may check the student out through the high school office and the student must sign back in when he/she returns. The student may not be tardy to class. MS/HS students should not be in the building during lunch unless supervised by staff.

### **After School**

Following the last bell of the day at 3:15, students who are not involved in after school extra-curricular activities must go home. If you cannot pick up your student by 3:30 Monday-Thursday and 12:45 on Friday, please make other arrangements. Students are not allowed in the building after 3:30 unless supervised by staff.

### **Crisis Management/Drills**

A crisis management plan has been established in case of an emergency. Periodic drills are performed so students and staff are prepared.

### **Food Services**

#### **Hot Lunch**

A hot lunch meeting all state nutritional requirements is prepared daily and is available for purchase.

#### **Snack Bar**

A snack bar is available to all GCS students. Each weekday has a unique menu. The snack bar also offers POWERade, bottled water, and milk each day.

#### **Lunch Payment**

Lunch should be paid for in advance on-line (FACTS) or at the office.

#### **Lunch Policy**

An e-mail is auto-generated daily when a student has \$10 or less in his/her account.

### **Illness Policy**

Please do not bring your child to school if they are running a fever (100 degrees or higher), vomiting, have diarrhea, or have a contagious illness. Your child should be free of symptoms for 24 hours before they return to school without the help of medicine. If your child becomes ill while in our care, we will call you and ask you to pick them up.

### **Immunizations**

All students must submit verification of state-required immunizations before the first day of school (State Law).

### **Insurance**

Primary coverage is the responsibility of the parents. The school provides a secondary insurance. More information is available through the school office.

### **Lockers**

Lockers are provided for students in middle school and high school. The school will provide the lock. A student may use only the locker assigned to him/her. Lockers must be kept neat at all times. No food should be kept in the locker for more than one (1) day. There is to be no writing on the lockers. Pictures taped on the inside of the locker must reflect Christian character and Biblical morality.

### **Lost and Found**

Lost items are collected in the front office. All unclaimed articles are given to the needy periodically.

### **Medications**

Gateway Christian School is not allowed to administer any medications such as Tylenol, Pepto-Bismol, etc. If a child does take a prescription medication and will need to take this medication at school, the school must have a permission slip filled out by the parent (as well as a form filled out by the physician, if it is a long term medication). The medication

must be sent in a prescription bottle with the dosage and the child's name on the bottle. The teacher will then keep a log of when medication is administered.

### **Office Hours**

The secretaries are in the offices from 8:00 AM – 4:00 PM Monday through Thursday and 8:00 AM – 1:00 PM on Friday. All messages left on the voicemail after hours will be retrieved the next business day.

### **Phone Use**

Students are not allowed to use the phone in the school office unless it is an emergency. Students must secure their teacher's permission before using the school phone.

### **School Closure or Delay**

#### **School Closure**

The decision to close school due to weather will be announced on TV stations and communicated via Parent Alert from FACTSI.

#### **Delayed Schedule**

School begins at 10:15. No Kindergarten Classes Will Meet. Extended Day opens at 7:00 am. The dress code for delayed schedule days will be that of "Friday/Spirit Day" (see *Uniform Dress Code - Friday/Spirit Day*).

### **Traffic Flow**

#### **Drop-Off/ Parking**

The parking and flow of traffic for MS/HS building will be determined once the building is finished.

#### **Automobile Privileges**

Only students at GCHS with valid driver licenses are allowed automobile privileges. Automobile privileges may be revoked at any time if the student does not adhere to the following rules:

- Students must have a valid Driver's License.
- Students drivers can only park in designated areas.
- Students must have permission to go to their vehicles during school hours.
- Students must not drive carelessly or recklessly in the parking lot.
- Driving privileges may be revoked on a first offense.

#### **Morning Entry**

Middle school and high school students will enter through the north door of the church building once the bell rings. Any students arriving before 8:00 AM must stay outside on the north side of the building until the bell rings.

### **Visitors/Volunteers**

Anyone (parents and visitors) on campus who is not a student or part of the staff should check in through the office.

Volunteers and visitors on campus should adhere to the same guidelines as the students and faculty in regard to modest dress, no alcohol, drugs, or tobacco consumption or inappropriate public displays of affection.
